

Attach attested photocopies of the following documents with the application form in the following sequence

Note: Check the relevant box for the attached documents

- Three Passport size-colored photographs of the applicant attested on the back.
- Two copies of detailed Marks Certificates of examination on the basis of which admission is sought (F.Sc , An equivalence certificate from the Inter-Board Committee of Chairman if the qualifying certificate from an Institute abroad.
- A Copy of Secondary School Certificate (Science / equivalent)
- Two copies of domicile certificate (Domicile certificate once submitted with the application form will not be changed)
- A copy of Computerized National Identity Card of the candidate or Computerized Form B, copied Full size paper
- A copy of computerized National Identity card of the father of the applicant copied on Full size paper, if the father is not alive, a copy of the National Identity Card of the mother or guardian should be attach with the admission form.
- A copy of attempt certificates from the concerned BISE, if the period between SSC and F.Sc is more than two sessions
- Undertaking on judicial stamp paper of Rs. 30-duly attested by notary public Political Agent as per specimen given in the prospectus admission (only after admission)
- Copy of Degree and Detailed Marks Certificate of all professional examination on the basis which admission is sought

IMPORTANT NOTES / INSTRUCTIONS

1. All applicant must appropriately fill the admission form and undertaking. Incomplete / Not properly fill form will be rejected. Avoid writing / Cutting while filling the form
2. The undertaking agreement must be filled by the candidate & Judicial bond of Rs 30-and should be duly attested by the First Clans Magistrate. The specimen Performa for undertaking is attached with the application form
3. The domicile, DMC of FSc (Pre-Medical) Equivalent examination, SSC and other certificates once submitted with the admission form cannot be changed and shall be considered as final. Revision of result or improvement of marks by the board/ IBCC after the finalization of merit list shall not affect the merit list of admission of current year in any way. All the above-mentioned certificates issued after the date fixed for receipt of application forms shall not be entertained.
4. Application form with any false statement by the candidate will be rejected.
5. If any certificate submitted by the candidate is found false, or forged during his/her study period his/her admission shall be cancelled forthwith and he/she shall be blacklisted for admission to any professional colleges in Khyber Pakhtunkhwa.
